What is a Direct Payment School?

Direct Payment Schools

NC private schools that accept direct tuition payments from SEAA



Accept ESA+ and Opportunity Scholarship program funds



Awarded student must be enrolled and attending for SEAA to send funds



School must be active school choice in MyPortal for SEAA to send funds

Direct Payment School:

ESA+ Sends Funds for Tuition/Fees

Certification (a school responsibility)

Certification

- School confirms that a student is enrolled
- School provides the cost of tuition and fees



once a year, in August



Endorsement: Fall & Spring









<u>Verify</u> student is attending *and* <u>approve</u> the funds that will be disbursed (paid)



<u>Confirm</u> school choice is correct and <u>approve</u> the funds to be sent to school

Typical Timeline

AUGUST: Certification

August / September: Endorsement and Payment to Schools (FALL)

January / February: Endorsement and Payment to Schools (SPRING)





Direct Payment School:

Funds remaining after tuition and fees are sent

ESA+: Remaining funds to ClassWallet

After tuition and fees are paid

If your school's reported costs are less than your award amount, the remaining ESA+ award funds will move each semester to ClassWallet to use for *other* Allowable Expenses.

TIMING: If your school is efficient with Certification, and your school and you are both efficient with Endorsement, fall funds will be in ClassWallet by mid-September, and spring funds by early February.





ESA+ Minimum Spend Requirement

ESA+ Parent Agreement: #5

 Parent agrees to use at least \$1,000.00 per year per student for school tuition and/or other allowable expenses in ClassWallet.

 If at least \$1,000 is not spent by the end of the school year, the student will not be eligible to remain in the ESA+ program.






What is ClassWallet?

a separate company that contracts with SEAA

 an online platform that hosts the electronic account on behalf of the ESA+ Program

- where ESA+ families use scholarship funds to:
 - →make a payment to a service provider
 - →purchase products that are ESA+ Allowable Expenses

- <u>✓ Tuition and Fees</u>
- <u>✓ Tutoring</u>
- ✓ Educational Therapy
- **✓** Curricula
- ✓ Educational Technology

These topics are links to explanations about WHICH expenses are allowable, and HOW parents pay for them

- ✓ Transportation ESA+ funds may be used for transportation to/from educational services or activities. Visit the Search for a Provider portal and enter the search term "transportation" to see a list of registered providers.
- ✓ Textbooks Must be required by a nonpublic school and related to one of the following academic subjects: math, science, English/language arts, social studies, or foreign languages.
- ✓ Standardized Tests Fees for nationally standardized tests (home school students only)



IMPORTANT ESA+ REMINDERS

Parents should check MyPortal once a week:

- Are there items on the To Do list?
- Look at Notifications. Maybe you've missed an email!

ESA+ students need updated documentation of a disability every 3 years (3 years from the evaluation date on file).

HOWEVER: Parents, you will renew annually so that the ESA+ staff know you want your student to continue next year.

ESA+ is **not a reimbursement** program.

- Very few exceptions (mainly the ESA+ Reimbursement Schools)
- Do not purchase items or pay for services with the intent to submit a receipt.

Public School? If a student will be in the public school, full-time, in their assigned district, then they are **not eligible for ESA+**.

ESA+ is not available to students who are enrolled in their regular public school (including charter schools).
