Summer is not funded separately.

Students who attend a **Direct Payment School** may have funds remaining to use for summer expenses after ESA+ has paid fall and spring tuition.

Students in **Home School** may have funds remaining to use for summer expenses after making purchases & paying for services through the school year.

ClassWallet Access



When is ClassWallet closed?

ESA+ closes the platform in June for end-of-year accounting

ClassWallet Closes:

- on **June 22 at 5:00 p.m.** All expenses for this school year must be submitted by that deadline.

Plan to Submit Expenses by May 31

- Submit orders and invoices as early as possible to allow time for potential rejections, supply chain delays, or vendor issues.
- **NOTE:** Refunds issued after the school year ends cannot be returned to your account.



CLASSWALLET

When does ClassWallet re-open?

- on **July 13 at 9:00 a.m.**



- Families with rollover funds can access their accounts at that time.
- Families that have completed all program tasks will receive their 2026-27 funding beginning in August.

Timing: *important dates*



Rollover Funds

If your student will roll remaining funds forward from one school year to the next ...

Even rollover funds may only be used for expenses from the current school year. They cannot be used to pay for expenses from a previous school year.



Paying for Summer Services

Plan for June / July / August

- Prepay for summer expenses that take place through August 31*

OR

- Pay for July & August expenses after ClassWallet re-opens / fall funds are deposited**

**pay attention to CW end-of-year close dates!*

***once CW re-opens families can't pay for any expenses that took place prior to July 1*
